- e) To provide general medical relief by subscribing to or establishing, if funds so permit charitable dispensaries, hospitals, clinics or to give medical relief to poor;





  - j) To feed poor and disabled persons for maintenance of beggar homes or institutions for beggars and disabled persons;
  - k) For removal of doubts, it is hereby declared that the funds of the Trust should not be utilised for any purpose other than objects of the Trust or for the benefits of author of the Trust or any person who has made substantial contribution to the Trust.

5. a) The Trustees shall hold office during their life un-less they vacate the office earlier. Shri Goutamchand Surana shall be the Managing Trustee durin his life time and not liable to be removed from such office except for branch of Trust or misconduct;
- b) In the event of any vacancy arising in the office of the Managing Trustee by death, resignation or otherwise the next senior most Trustee shall act as Managing Trustee, the seniority in respect of the Trustee herein being reckoned in the order in which the names of the Trustees are mentioned in the deed.
6. In the case of any vacancy in the Trust board arising by death or resignation or otherwise, the remaining Trustees will have full powers to represent the Trust Board. The Managing Trustee shall have, in such an event, power to co-opt a Trustee to till up the vacancy.

7. The Trustees will be entitled and be at liberty to accept gifts or any voluntary contributions from any person, instal charity boxes and or otherwise collect subscriptions or donations to augment and the Trust Fund and use such moneys for the objects of the Trust. It shall always be open to the Trustees in their absolute discretion to accept or refuse any such donations, gifts and/or contributions.

8. The Trust shall be managed by the Managing Trustee who shall have the powers of day to day management and administration of the Trust.

9. Without prejudice to the generality of their power the Trustees shall have powers:-

- i) To employ clerks and other employees, agents, bankers, lawyers, accountants and others and at such remuneration as they may think fit;
- ii) To delegate any powers to one or more of their body;
- iii) To delegate any power as they can lawfully delegate to any person and to execute such power of attorney as they may think fit for purpose;
- iv) To withdraw any power or revoke any appointment of any employee or attorneys;

v) To let any portions of any immoveable property forming part of the Trust Fund, at such rent and for such period and on such terms and conditions as they may think fit and to accept surrender of any letters;

vi) To borrow money with or without ~~xxxxxx~~ security or pledge, mortgage or otherwise charge any of the properties belonging to the Trust for purpose of raising loan;

vii) To maintain banking accounts in the name of Trust and to make the account operatable by such one or more of them as they may think fit;

viii) To determine who shall be the first named as regards investments in shares, stocks, debentures and other securities and other investments;

ix) To appoint proxy or proxies for voting at any meeting of creditors, contributaries, share holder or others;

x) To allow any investments to stand in the name of my Ben

10. It is declared and understood that it shall be lawful for the Trustees to resolve and frame the rules for the conduct and management of the Trust or Trust Fund or for the carrying out the objects of the Trust and such resolutions and rules framed, amended, altered or substituted shall have the same force as if they have been incorporated in the original Trust hereby created but not repugnant to the objects of the Trust.

11. The Trustees shall have the power to sell, convert, or otherwise release of any trust properties or invest the same in any form of investment or change the form of investment where they are satisfied that such investment will yield a reasonable income or where it is deemed expedient or necessary for carrying out the objects of Trust.

12. The Trustees shall keep proper books of accounts of the income and expenditure of the Trust which shall be closed every year.
